ANNOUNCEMENT: CPT Coding Effective January 1, 2024

The American Medical Association (AMA) has made Current Procedural Terminology (CPT) code changes to the 2024 edition of the CPT coding manual. In addition, the CMS has also made changes to Healthcare Common Procedure Coding System (HCPCS) codes.

Sonora Quest Laboratories has implemented these changes effective January 1, 2024. The changes for 2024 affect the way we bill some of our tests. Please note that these changes will not impact our service offerings or how you order them but simply how we will bill third-party payers.

The summary below outlines the 2024 CPT code changes that affect Sonora Quest Laboratories' published test offerings. These tests may also be included in panels or profiles.
